



BRIDAL MAKEUP SERVICE CONTRACT

THIS MAKEUP SERVICE CONTRACT is made and entered into as of _____, by and between (“Bride”) _____ whose address is _____

and (“Makeup Artist”) Kim Jones whose business address is undisclosed until contract has been signed and completed. In consideration of the mutual covenants herein contained and, intending to be legally bound hereby, the Client and the Makeup Artist agree as follows:

1) Makeup Artist’s obligation to give services hereunder is subject to the unavailability of the Artist as a result of sickness, accidents, acts of God and other reasons beyond the Artist’s control.

Kim Jones is acting as a non-exclusive independent contractor for the client. By signing this contract client removes provider from any person responsibility if there should be any damages incurred to client and/or bridesmaid(s), due to sensitivity or allergic reaction from products used during services, and that services are commissioned at own risk.

The artist will set up one half hour before the agreed upon "start time." Artist will arrive on the time agreed upon and stated in this contract. Artist will work straight through until the completion of the services specified in this contract or the specified time of departure, whichever comes first. No exceptions will be made for any reason i.e. a forgotten tiara, lunch break, dress alteration etc.

A "set up" table/work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. (I will bring my lights...just need outlets)

5) PAYMENT: Your wedding date and time is secured ONLY with a signed contract and paid deposit. Dates are not held without a paid deposit. A 50% non-refundable deposit is due upon signing your contract. This deposit will be credited toward your balance of the wedding day. The remaining balance is due on wedding date before makeup application. The Client agrees to make the following payment in U.S. funds to the Artist:

a) Deposit. Client will pay \$ _____ of the payment to Artist as a cash or check deposit at the trial run.

b) Payment of Balance. The Client will pay the Artist the remaining balance of \$ _____ in cash to Kim Jones.

6) Touch-Up: \$95 per hour or Day Rate: \$450 Half Day Rate or \$550 Full Day Rate (pertains to client if Artist is needed for after the initial application for (pictures after wedding). Yes No If Yes, how many hours: _____?

7) Travel Rate: must give artist zip code of wedding destination to calculate miles Client is responsible for parking fees.

8) CANCELLATIONS. In the event Client cancels the event, Client will lose the deposit made to the Makeup artist.
In the event that Makeup Artist cancels for any reason, 100% of all monies/deposits will be refunded to Client within seven (7) days, payable through PayPal.

9) PUBLICITY RELEASE: Client gives consent and approval for Kim Jones, Makeup Artist, to use any pictures on her website – and / or in any brochure, flyer or other advertising it deems necessary - any and all photographs, video, audio, and any other digitally or chemically stored media that is captured or recorded by Kim Jones and any and all of her representatives or agents. Client agrees to release any and all claims regarding use of his / her image for such purposes. Client also agrees to release name and contact information of professional photographers and / or videographers used for recording any event for which Kim Jones has been contracted to do makeup. Client agrees to release to Kim Jones, Makeup Artist, use of said photographer's and videographer's photographs and recordings.

10) MISCELLANEOUS: The Wedding Agreement and the attached riders, if any, set forth the entire agreement between the parties, and may not be amended except in writing signed by both parties. This Bridal Makeup Service Contract will be governed by and construed in accordance with the laws of the State of Texas, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Client and the Artist arising out of this Bridal Makeup Service Contract, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees. By signing this contract, I have read and understand all the terms and conditions outlined above. I understand that I will be financially responsible for self along with bridal party and all deposits made are non-refundable. I will abide by this contract. This contract is binding.
